MINUTES OF THE DECEMBER 19th, 2007, IPNA MEETING

WELCOME AND INTRODUCTION OF NEWCOMERS

Anda Olsen welcomed everyone to the meeting. She announced the police officers were present and started with their portion of the meeting.

POLICE OFFICERS' REPORTS

Investigator Peek introduced Warren Atkinson, Community Prosecutor for Zone 6, and another police lieutenant.

Inv. Peek said there has been a recent rash of car break-ins, including one on North Highland where the perpetrator left his Fulton County Jail bracelet in the car. There is a warrant out for his arrest.

He said the APD has set up several road blocks in the last month. He reminded everyone to take packages out of your car. He stated there were three burglaries in Inman Park last week. Security Patrol is upgrading to three shifts per day, 7 days a week.

He reminded everyone to let SP know if you are going to be out of town and if anyone will be coming to your house. Bill Hagan announced a form is posted on the IP website for Security Patrol members to request SP to pay extra attention to your house while you are out of town.

Warren Atkinson, Community Prosecutor for Zone 6, spoke up to address concerns about Cori Williams (the defendant in the Terry Williams murder case) being granted bond last Monday. There was much discussion about the late notice we received about when the hearing would be held. Warren said he is normally notified when a case is coming up. The information he received about this hearing was it would be for discovery only. He said Judge T. Jackson Bedford determined because of the defendant's age and lack of prior felony record and ties to community he was entitled to a bond, which was set at \$92,000. So far he has not been released. The thinking is he won't be able to make the bond. The judge has discretion, which he exercised. People have been asking Warren, how could this happen? He said he understands our concern completely and reminded everyone to keep in mind this is only one part of the process; there is a very good case and he believes we will get a conviction. If the defendant makes his bond, he is to stay out of Zone 6. Warren will forward us a photo. There was more discussion which, in the interest of time, Anda said we should wrap up, saying we need to move on from this as we cannot assume common sense will prevail. Bill reminded Warren we are constantly being promised photos so we can watch out for perps in our neighborhood and we never receive them. Warren said he will forward photos to us from now on. Warren also announced there will be an open house January 24th at the new Community Prosecutors office, 772 Edgewood Ave from 5:00 p.m. until 7:00 p.m. This will be the grand opening of the office.

Anda announced we would return to the agenda; she welcomed everyone and asked for newcomers. Brian Coyle said he moved to Sinclair Ave. in April. Harry and Gwen Hoffman moved to Seminole Ave. Gwen shared her outrage at the Williams bond issue. Anda said we share her passion.

MINUTES OF THE LAST MEETING

A motion to accept the minutes from last month's meeting was made, seconded, and carried.

ANNOUNCEMENTS

1. Danny Feig-Sandoval announced Dr. Amy Varner is having her official open house tomorrow from 4:00 p.m. - 6:00 p.m. There will be lots of food.
2. Steve Hays announced Bob Eberwein will be stepping down as director of the Trolley Barn as of January 1st and Linda Dunham will be taking his place.
3. Judy Clements announced she is hoping to get the Festival volunteer sign-up website up and running soon. She reminded everyone the most exciting volunteer job is trash.
4. Danny announced the next Festival meeting will be January 10th at 7:30 p.m. at the Trolley Barn. He reminded everyone to start thinking of their list of people to buy house tour tickets for. If you have a business, tickets make a great gift.
5. Oreon Mann announced the next Book Club meeting is January 22nd. The book is *Change Me Into Zeus' Daughter* by Barbara Robinette Moss. The meeting will be held at 814 Virgil St. at 7:00 p.m. You have one month and one week to read the book. Bring a covered dish to share.

ELECTED OFFICIALS' REPORTS

Jay Tribby, representing Councilperson Kwanza Hall's office, said he is still working on the 670 Dekalb Ave. issue with Jonathan Miller, Tamara Jones, and others.

Atlanta BeltLine Inc. closed a big deal about a month ago [joint Venture with Barry Real Estate who purchased the northeast portion of the BeltLine right-of-way] and have been unable to meet. As soon as there is a meeting scheduled he will let everyone know.

He said we also have recently learned there have been preliminary plans to put a cell phone tower on the edge of Bass Field. We are working on that; the City has a couple of different routes to take. Jane Bradshaw asked what company? Chuck Clarke said it is T-Mobile. Anda Olsen expressed our main concern about Bass Field is it is an area we want to have a lot of flexibility

in for the future; plus we do not want a cell phone tower in a historic district.

Anda said both Jay and Kwanza have been very helpful on several code enforcement issues around the neighborhood. Jay said he is also working a lot on watershed issues. Billing issues and strange leaks are popping up on properties. If you have an issue let Kwanza's office know. (404-330-6038 or khall@atlantaga.gov)

Jay also said last Saturday two homes in the MLK Historic District burned to the ground. One family lost their home as it completely burned to the ground. The head of the house is a war veteran. On Saturday, Kwanza will announce the establishment of a fund to support the displaced family: it will be the Billingsly Family Restoration Fund.

Anda expressed her appreciation to Kwanza for his recent organization of the community cleanup in Old Fourth Ward. Plenty of volunteers picked up lots of trash. Jay thanked IPNA for sending a representative to the master planning sessions for the Old Fourth Ward.

IPNA OFFICERS' REPORTS

PRESIDENT: Anda Olsen

Anda asked how many people reached out to neighbors and newcomers during this month? There was a good show of hands. Anda also gave a big thank you to Ray Harbour and Karen Heim for the fantastic holiday party this year.

ZONING: V.P. Drew Evans

1. NPU-N Report by Jonathan Miller, NPU-N Representative for IPNA:

- A. 299 Moreland Ave – the former laundromat building next to the paint store. Owner wants to put in a restaurant. The owner wants a variance as there is not enough parking. Candler Park said no. Jonathan has heard the owner is now considering a smaller restaurant. There will be a presentation later.
- B. 757 Edgewood Ave – NPU-N vote tomorrow; he will vote yes tomorrow night with conditions.
- C. Proposed ordinance to modify requirements for Edgewood Retail District – want to take control of traffic calming and green space money away from Sembler and give to it to the City. No response has been received yet. More to report next month.
- D. Proposed ordinance to regulate valet parking (07-0-2418) – A report will be made next month.
- E. Jonathan said he has enjoyed being IPNA's NPU-N rep and would like to do it again. A motion was made, seconded, and passed unanimously.

2. 715 Edgewood Ave – ZRB Board did meet and approved rezoning to C1. They also approved the inclusion of a condition prohibiting a liquor store.

3. 299 Moreland Ave – An informational presentation was scheduled for tonight but the applicant is not here.

HISTORIC PRESERVATION: V.P. Chuck Clarke

1. 957 Austin Ave - demolition was approved.

2. 350 Sinclair Ave - Adam Stillman is owner/architect. This home burned down two months ago. It was 1½ stories at 24 feet high. He proposes to build a two story house at 29 feet high. He is asking for a Certificate of Appropriateness and height variance. Height restriction is 19 feet because of the contributing homes along the block-face. There was an immediate neighbors' meeting last Sunday. Both votes were split. On CoA the vote was 6 for and 3 against. On height variance the vote was 5 for and 4 against. The owner spoke and thanked everyone in the neighborhood who helped out the night of the fire and later with contributions of clothing, etc. He summarized as follows: There are four contributing structures on his block; the others are all one story. The house which burned had a flat roof slope which is no longer allowed. As the roof had to be made steeper it makes the house taller. He proposes to build the house 30'10" wide, which is narrower than before to increase distance between houses. He wants to put the garage under the house in the basement to free up more of the backyard and reduce lot coverage. He pointed out the houses across the street are 30 and 31 feet tall.

Allen Travis, a neighbor, spoke up and said the tax records show the previous house was only 25' wide and pointed out that the façade width at the street is the most important for compatibility. His protest was a two story house will overwhelm the other houses on the street and pointed out even the two SPI-5 houses on the block are 1 ½ stories, not 2. He pointed out that if this variance is granted it will be harder to deny a similar variance to adjacent houses and would change the character of the street. Another immediate neighbor said she wishes he had made more of an effort to blend into the block by minimizing the scale at the street; since he is an architect he could do it for himself.

Another immediate neighbor also spoke up. He and several others support the application. He said Adam has taken their concerns and opinions into account, and is trying to rebuild something which will give him what he had before. The floor plan is the same as what was there before but he cannot make the roof as flat. This neighbor reiterated the support of neighbors and pointed out there were 6 in support and 3 against.

Rick Bizot stood up to clarify the differences between the house before and what is proposed. The proposed house is a full two story with the full width at the street and this is what the neighborhood needs to take into account. A motion was made and seconded to deny the variance.

Jonathan Miller stated the Historic Regulations came into effect on his watch and the intent was to maintain the character of each block-face in the neighborhood, not just the neighborhood as a whole or even each street.

Anda Olsen asked for a vote in support of the motion to deny. 19 voted to deny. She then asked for those against the motion (which are voting to support the variance). 13 voted against the motion to deny. The motion to deny passed. Another motion was made to deny the Certificate of Appropriateness. The motion was seconded. 19 voted to deny and 13 voted to support. The motion to deny passed.

3. Bill Barnett of Homebuilders came to make a presentation for informational purposes only. He referred to the first house

of three to be built on the Lizzie Chapel property. He presented drawings showing the front and side appearance of the three homes and answered questions. What about the large tree between the church and the first house? His intention is to keep the tree. How deep are the front porches? They are ten feet deep. Are any of the houses sold yet? No, the first house will be to specifications and they hope to presell the other two. What is the square footage? First one is 3,200 ft. Chuck will ask for deferment at UDC since this was not on the agenda and we did not vote.

PUBLIC SAFETY: V.P. Bill Hagan

1. The Inman Park Security Patrol car is outside; go take a look.
2. Bill reminded everyone: *Do not leave stuff in your car.*
3. There was an operational meeting for Security Patrol last week. There is a lot of room for help. There will be a meeting to work on development, fund raising, etc., tomorrow night at 7:00 p.m. at Betty Ridderhoff's house. If you are interested, please attend. Let Bill know if you will attend.
4. Anda Olsen said if anyone has experience setting up Paypal we need help with this; we are trying to make SP dues really easy to pay.

Bill pointed out there are 3 constituents: residents, small commercial, and large residential

Anda gave a big thank you to Bill for all of the work he has done getting the car and expanding Security Patrol.

PLANNING: V.P. Patrick Bradshaw

1. Tomorrow is the Beltline steering Committee meeting. It will cover the North Avenue park and go over the master plan and construction. Last week Patrick and Jonathan Miller attended Atlanta Connects – emphasized traffic calming, maintenance of the existing road system, and more transit. These meetings will be held throughout the year. If you have any concerns, issues, etc., contact Patrick. Jonathan said tomorrow's meeting is open to the public. Atlanta Connects says jobs follow people. As we are getting more residents, more jobs are coming our way. A transit plan is way overdue.
2. 280 Elizabeth Street (Dad's Garage property) – there will be a meeting the first week of January. Watch the Yahoo board and e-mail him if you are interested in attending.

TREASURER: Leslie Ward, Treasurer

1. Recurring Budget Expenditures
 - a. September and October *Advocator*: \$3,359
 - b. Beautification: \$940
 - c. Security Patrol: \$2,460 – in December we increased the patrol hours. The monthly amount is going to go up. Half of the SP budget is slated to come from development (fundraising other than dues). Help us come up with ideas for funding. She will talk to Bond next week about ways they can facilitate the payment process and streamline it.
2. Traffic Calming – we need to vote on an additional \$5,000 for design work. This money was already budgeted. Danny Feig-Sandoval presented the plans and had added a couple of features. A motion was made, seconded, and approved unanimously.

SECRETARY: Ellen McManus, Secretary

Anda pointed out we are trying to get the membership renewals in early to give Betty more time to put together the directory. Jonathan Miller asked if one check is okay. Leslie Ward said yes.

COMMITTEE REPORTS

1. Traffic Calming – Danny Feig-Sandoval said he will post the most recent drawings on the Yahoo group and website. We need to turn the drawings in to the City before February 1st so the money will remain allocated. There was much discussion of various spots. Judy Clements made a motion to eliminate the Elizabeth/ Edgewood option, and to have Danny hold meeting(s) in January to decide which options to submit and then to move forward based on that decision. Motion was seconded and approved.

NEW BUSINESS/OLD BUSINESS

New Business: Anda Olsen asked Rick Bizot and Steve Hays to head up the Nominating Committee for the next IPNA Board. Steve said he will be traveling too much to be effective but recommended Bill McMurry. Rick said he would assist if someone who had been on the Committee before would be the head.

Old business: There was no old business.

MOTION TO ADJOURN

Meeting was adjourned at 9:48 p.m.

INFO ON THE BOND GRANTED IN THE TERRY WILLIAMS MURDER CASE

On Monday Dec. 17th, 2007, Judge **T. Jackson Bedford** heard a request for bail for 19-year-old **Cori Williams**, charged in the murder of **Terry Williams** [no relationship] in front of Terry's In-man Park home on May 22nd, 2007. This defendant has been indicted on 6 counts: 2 counts of aggravated assault with attempt to rob and 1 count each of felony murder, criminal attempt to commit armed robbery, murder, and possession of a firearm during the commission of a felony. Terry was shot in the head during the course of an armed robbery and died of that wound. It was a sudden, random, stranger on stranger crime. Unexpectedly, Judge Bedford granted bond (we were told he did not release murder suspects)--he set bond at \$92,500 with several conditions.

Since the bond hearing, I have been gathering a lot of information from a variety of sources. I will try to convey the information here and address many of the concerns and questions raised about what I believe is a terrible and unwarranted ruling. Terry's family, friends, neighbors, the local business and residential communities, and the District Attorney's Office have all expressed outrage at this decision.

Since there has been much discussion over numerous e-mails, e-mail lists, and personal conversations, there may be some repetition here of information you already know. Also, as this will be quite lengthy, I have opted for complete over succinct.

First, here is my non-lawyer understanding of bond (feel free to send any corrections).

There are a number of considerations for a judge to rely on in setting bond--his function being to insure that the accused shows up for trial and that releasing the accused poses no significant risks to the community. He is NOT to consider any of the facts or evidence regarding the guilt or innocence of the accused for the underlying crime. Factors to be considered include: the seriousness of the offense, the accused's ability to pay, penalty, the accused's character and reputation, health, probability of the defendant appearing to serve sentence, forfeiture of other bonds, is defendant a fugitive, prior criminal record, length and character of residence in the community, employment status and history, past history of responding to legal process, roots in the community, and that the defendant does not pose a significant risk of fleeing, threatening the community, committing another crime, or intimidating a witness.

There are no crimes without eligibility for bail. Anyone accused of a crime is presumed innocent until they are convicted of that crime in a trial. There is a right to bail under the 8th Amendment to the Constitution and the Georgia Constitution: "*his traditional right to freedom before conviction permits the unhampered preparation of a defense, and serves to prevent the infliction of punishment prior to conviction. . . . Unless this right to bail before trial is preserved, the presumption of innocence, secured only after centuries of struggle, would lose its meaning.*" *Stack v. Boyle*, 342 U.S. 1, 4 (1951)

Now all of that makes some sense but here are some facts that make no sense. In Georgia bond hearings the juvenile criminal record of the accused cannot be brought up or considered! In Fulton County there is such a severe shortage of jail space that judges are releasing many, many more, and more dangerous, defendants than they ever did in the past (this despite the fact that Fulton is spending \$35 million a year out-sourcing jail space from other counties), the jail has been so overcrowded there have been several Federal suits brought against it, and this is all multiplied by a dramatic increase in Atlanta crime rate. In the first 6 months of this year [2007] compared to the first 6 months of last year [2006]: homicide is up 48%, robbery is up 25 %, home burglary is up 17 %, and auto theft is up 18%! Fulton County District Attorney **Paul Howard** reports about 40 percent of murder defendants are released on bond, with 17 bond forfeitures currently of murder defendants who failed to appear at trial!

Also, there seem to be no real rules judges have to follow in determining bond, I have heard it often seems to be by whim, yet there is little recourse against that de-termination!

“The amount of bail to be assessed in each criminal case is left to the sound discretion of the trial judge, and in the absence of clear abuse of such discretionary power, his action will not be controlled.” Reid v. Perkerson, 207 Ga. 27 (4), supra; Sanders v. Paschal, 186 Ga. 837 (2) (199 SE 153).

“The granting or denial of bail will not be set aside unless there is a manifest and flagrant abuse of discretion.” Jernagin v. State, 118 Ga. 307, 308 (45 SE 411) (1903).

After the bond hearing for the suspect in the Terry Williams murder, many people attending the hearing were disappointed in the way the prosecutor, Assistant District Attorney **Eric Dunaway**, performed. They reported he seemed to be lackluster, disorganized, unconvincing, and unconvincing. The defense attorney (I’m told a family member of the defendant may be paying for this private counsel) was quite the opposite--on the attack against the witnesses, emotionally making the case for release, etc. Another problem was the community received very little advance notice of this bond hearing (late Friday afternoon for the Monday morning hearing), although assurances were given to me when I spoke with and met with the District Attorney, that we would be kept in the loop. A larger turnout from the community may have had an additional influence on the judge, but some miscommunication definitely caused the DA’s office to drop the ball here since we have been told over and over again that community turnout at hearings and trials can have a vital affect.

I spoke with Eric Dunaway after the bond hearing and several times since. He was straight-forward answering my questions and seemed knowledgeable about the case, but I did not see his court performance which, as I have said, was reported to be inadequate. He did clear up several issues for me, like the impression that no one in court responded to the judge’s question whether releasing the defendant would be a threat to the Little 5 Points area. Actually the Judge asked whether anyone had any other specific evidence of why Cori Williams would be a threat to the neighborhood, that is other than the obvious concerns that this crime brings up. For instance any history of criminal activity, fights, threats, drugs, etc. Since this may have been one of the defendant’s first times in this area, no one had such evidence.

Fulton DA Paul Howard gave this powerful written statement to Creative Loafing about the bond being granted:

“The fact that a bond has been set in this case is a disgrace. My office strenuously opposed it; the people who live and work in the Little Five Points community were pre-sent in court, along with the victim's family, and they all opposed it. Why a judge would allow a defendant who murders a citizen by shooting him in the face while attempting to rob him, to be released from jail, defies reason and spits in the face of justice.”

I also contacted and spoke at length with a number of people I know and trust (including two current and one former Fulton County Assistant DAs who have worked with Mr. Dunaway, two criminal defense attorneys, an Assistant Senior State Attorney General, a former Federal Prosecutor and an Atlanta Deputy Chief of Police) to get their opinions about what happened. All of those familiar with Assistant DA Dunaway had high praise for him and reported he is an excellent, highly competent, and thorough attorney who consistently gets convictions. He is part of the DA’s elite Serious Crimes Section. They also gave me some education on some realities of the system. Without exception, they all said it is very early in the process and not to be discouraged since this was not a setback to the case itself. It seems granting bond in a case like this, while not typical, is also not extremely unusual. The amount set is considered pretty high and most felt it would be unlikely the defendant could raise the funds (either by spending, and thus losing, over \$11,000 or having a large property asset to put at risk). Also, there are several conditions on the release if bail is raised, including no use of drugs or alcohol, being employed within two weeks, living at his parent’s home, being home everyday between 6:00 p.m. and 7:00 a.m., no contact with any of the witnesses, and staying out of the L5P area. **However, one condition set by Judge Bedford defies common sense and credulity: although there are 4 GUNS in the house, the accused can live there if he is bailed out since his father is supposed to keep the guns under lock and key.**

You can check on the status of whether Cori Williams is still in jail by going to <http://www.fultonsheriff.org/>. Click on "Jail", scroll down, enter the booking number 0719194, and click "Search". However, the site reports the data is only updated once a day. The jail telephone number is listed as 404-853-2001, I don't know if there is more accurate information available by phone. As we are getting ready to publish this article (01/05/08) he is listed as still in jail.

If Cori Williams is released from jail, I’ll transmit that with his photo and description so the community can be on the look out for him violating the terms of his bond (if you’d like a photo now, request it at L5PPublicSafety@bellsouth.net).

There may be a motion filed by the prosecution to reconsider bond. While the reported poor performance by Mr. Dunaway at the bond hearing may have been just that, it may just be his low key style combined with the reality that prosecutors are constantly appearing before the same few judges (who are constantly hearing these types of cases) and get to know what judges want, usually just the relevant facts and without a whole lot of bombast. On the other hand the private defense attorney may have been playing to his constituency (those who’ve hired him to work for them) with more drama, despite arguing much that was irrelevant to a bond hearing. I’ve also heard from attorneys familiar with Judge Bedford who say he is considered a reasonably good judge.

Given all of this I completely disagree with Bedford’s ruling. On the night of the crime Cori Williams went to some friends looking for money to get out of town, which certainly sounds like he is a flight risk. However, the judge considers the facts that he did not in fact leave, nor resist arrest, and has strong ties to his community with perhaps nowhere else to go and hide, as evidence to the contrary. Maybe so, but then he didn’t know he would be caught, now he knows he is the suspect, some of the evidence against him, and the likely sentence he’s facing, and thus it’s reasonable to assume that get-out-of-town instinct will kick in again. Also, since his juvenile record (I’ve heard there is a fairly extensive one) isn’t considered, the judge does not have information available on many of the factors he is supposed to consider. Additionally, sending this defendant to stay in a home with 4 guns present is simply unconscionable. Finally, and most importantly, the judge is to consider the seriousness of the offense. If this wanton, heinous, depraved act, of suddenly and un-hesitantly pointing a gun at a stranger’s head and effortlessly murder him without provocation, is not evidence of someone who is a danger to the community, having a total lack of conscience or regard for human life, then what is? There is no doubt letting this individual back on the streets would produce a high level of fear in the community, similar to what was felt during the period between this crime and his capture.

That means that the Crown Vic will be moving twice a day most days, with a morning four-hour shift from about 7:00 a.m. to about 11:00 a.m., and another four-hour shift at night, usually from about 11:00 p.m. to 3:00 a.m. Those times will vary, of course, depending on officer availability and assessment of current crime patterns. too bad, because, as I said in last month’s column, “a highly visible law-enforcement presence deters crime ... this car is visible and sends an immediate, unmistakable message that it is here to thwart thugs.”

When you see activity next door or across the street that doesn't look right, it probably isn't. That's what 911 is all about. If “visitors” are innocent, the responding APD and/or Security Patrol officer can sort that out appropriately. For gentle readers, that isn't code for tazing folks, it means asking nicely, because there may be a legitimate explanation. But, sometimes there isn't. Squatters and urban campers risk life and property when they play house in our neighborhood, so when I see them, I call 911 or run 'em off myself (something Kathi discourages by asking, after such events, if she can review my life-insurance policies!). Chapter VI

OK, let’s get one thing out of the way. **David Simpson** and **Karen Goeckel** were the first to notice (and trumpet) this gaff, but someone would eventually have caught it, so I suppose I should thank them, and will as soon as I stop sulking. The other morning I was disturbed to hear from our Security Patrol that a home on Lake Avenue had been burgled. **Chief Peek** was the patrol officer that night and, while checking on vacation-patrol requests nearby, noted that this house, otherwise dark, had its front door wide open, not a usual event about 2 a.m. on a December morning. He investigated and found that someone had apparently entered through a pet door and stolen computers and other valuables, leaving through the front. **Inv. Peek** was puzzled because the home had a Security Patrol sign in the front, but was not on the list. Let me say several things about all of that.

First, when you leave town, even for a day or so, you may, as a Security Patrol member, request a “vacation check,” using the form on the Inman Park website. That means the Crown Vic visits your home at least once every shift and the patrol officer will do a physical check of the premises. Eligible members may make that happen here: http://www.inmanpark.org/public_safety_vacationpatrol.php

In addition, Zone 6 provides “directed patrols” to residents who request that. You can obtain that form here: www.npufatlanta.org. In the February *Advocator*, I will provide an e-mail address to send those to Zone 6, but for any absences until then, you may fax or deliver the form to Zone 6, using the number/address on the form. The residents of this burgled home had not asked for a Security Patrol check, and they had left the welcome mat out for the thugs who stole from them by having several days of newspaper deliveries in the front yard. *Duh.*

Second, this may seem a bit strong, though I feel strongly about it. In my opinion, it is a form of larceny to have a Security Patrol sign on your property without being a current member. Yes, of course, I know that many of us (including, as long as I am being critical, yours truly) have let that and any number of things miss a renewal suspense. But I am not really talking about that. I am talking about folks who, through long inattention or, worse, design, keep the sign in their yards and give the impression they are members without paying the price. That is not right. The Security Patrol, as an arm of the Inman Park Neighborhood Association, owes all residents general coverage, but those who keep the sign without keeping up dues are stealing from those who bear the burden. The level of debate there is pretty high, as are passions, and I encourage all to read through the several threads. **Bill Sanders’s** piece on the distinction between bail and bond is a great primer on the subject for lay folks (and this lawyer).

I will spell out more in another column, but for those interested in the patrol-car, we will soon have a tracking device installed that will record where the car goes. As I have told the officers, this is not an integrity-checker, but a way of accounting to the membership, and selling to prospective members, that the car gets around. Right now, the car is averaging between 20-30 miles per four-hour shift. And, it ain’t no Prius at the pump! In addition to recording routes, the device will text me when it exceeds X mph and when it leaves the neighborhood.

Please look for the separate piece on Page 13 in this same issue about how you can help with the problem of homeless people camping in the neighborhood.

Finally (a beautiful word, is it not?), we are working hard in the Public-Safety Committee, but we are not, Kathi assures me, perfect. The preliminary drawings for the neighborhood traffic-calming plan have been submitted to the City of Atlanta for a preliminary approval process. Once the City has reviewed these and either approved or denied them, we will then go through a preliminary estimating phase to see what the cost of these projects will be. Once we have determined our costs, we will have a better idea of which projects can actually get built. Depending on the budgets, we will then have to decide which projects get prioritized- that will be a fun process!!

After we have a final list of projects, we will go through a formal petitioning process, whereby we will need to get approval / signatures of a certain percentage of effected neighbors for each project. Once approved by the neighbors, we will begin the final design / engineering phase to determine the details of each specific project. This is a very slow process, so don’t expect to see crews working on these projects anytime soon. I wish I had more information with regards to schedule, but it is very difficult at this time to predict when work could begin. I will be posting notices / drawings as I get them on both the IPNA Yahoo Groups and the IPNA neighborhood websites.

STUNNING PHOTOGRAPHIC EXHIBITION AT CARTER LIBRARY

President **Jimmy Carter's** legacy of preserving some of the most beautiful and fragile land in the United States is on display at the Carter Presidential Library. The images in the stunning, new exhibit "Southwest Alaska: A World of National Parks and Wildlife Refuges, the Photographs of **Robert Glenn Ketchum**" will take your breath away.

Twenty-seven years ago, President Jimmy Carter helped preserve this beautiful landscape for generations to come. The Alaska National Interest Lands Conservation Act, signed into law on December 2nd, 1980, provided for the creation or revision of 15 National Park Service properties, and set aside other public lands for the United States Forest Service and United States Fish and Wildlife Service. In all, the act provided for the designation of 79.54 million acres (124,281 square miles) of public lands, fully a third of which was set aside as wilderness area.

World-famous photographer Robert Glenn Ketchum has captured the beauty and the fragility of this land in more than three dozen large format images. The photographs in this exhibit have been selected from his comprehensive 2-book Aperture release, *Rivers of Life: Southwest Alaska, The Last Great Salmon Fishery and Wood-Tikchik: Alaska's Largest State Park* the most complete photographic archive ever created of this area.

Photographers will appreciate Ketchum's skill. He and master-printer, **Michael Wilder**, were among the first Americans to work with Ciba-Ilfochrome print materials, and with this current exhibit, Ketchum has moved to new technologies and increasing print size. Some images in this exhibit are larger than life, and their startling clarity gives the boreal landscape a surreal quality. The richness and subtlety of these 30"x 40", 48"x 66" photographic prints are the incomparable results of someone that has been pioneering the exploration of color and scale for nearly 35 years.
