# Minutes of the May IPNA Meeting

President Andy Coffman called meeting to order at 7:35 p.m.

Guest/Newcomers: **Walter Johnson** announced that he and **Mr. On**, representing Cafe Izakaya were in attendance. They are planning a Sushi restaurant at 99 Kroger Street. **Noah and Alexandra Kronemeyer**, new residents along with their cat and Noah's four-year-old son have taken up residence at North Highland Steel on Elizabeth Street. **Mark Crump and Becca Dawsey**, 829 Virgil Street announced this was their first meeting.

## Minutes

Motion was made, seconded and carried to approve last month's minutes.

Announcement: **Pat Westrick** announced the May Porch Party would be held on May 30, Friday at 7:30. **Ginger Lyons** is hosting the party at the Inman Park Village Lofts. Details will be posted on the Yahoo website. All are welcome, just show up.

Elected Officials Reports: None. **Nan Orrock** arrived to welcome the new board members at the end of the meeting.

## Police Officers' Reports

**Detective Watkins** reporting for **Captain Schierbaum**, stated that there continues to be a wave of residential burglaries. A good description has been given of a 30 year old, slim, black male suspect. However, he has not been located. Detective Watkins encouraged neighbors to call 911 and report any suspicious behavior. Crimes of this nature are solved when neighbors are alert. Inman Park Security Patrol is not manned 24 hours a day; the first call must be to 911. The biggest asset for a community to fight crime is for citizens to be involved and attentive. Warrants have been secured for two suspects wanted for burglary. Their photographs were circulated. Arrests have not been made.

**Lieutenant Floyd** representing Zone 6 on behalf of Major Peek attested to the increase in residential burglaries. Focal points seem to be the five blocks surrounding L5Ps. The new trend is evening burglaries particularly at Elizabeth Street and North Highland Avenue, and Elizabeth Street and Lake Avenue. Pedestrian traffic is heavy at those points and the bad guys blend in quickly. Zone 6 is providing greater visibility on those corners. Car break-ins remain a chronic problem. Two suspects identified in the robbery on Lake Avenue were arrested in East Point. Attendees of the meeting had questions about reporting motorcycle noise ordinance violations, GBI crime lab reporting and police procedures. Lieutenant Floyd was available to further discuss issues following the meeting.

## Committee Reports

**Andy Coffman, President** presented the slate of officers nominated for 2014-2015. Dennis Mobley President, VP of Planning Michaela Kendall, Treasurer Barbara Leach were asked to stand and be recognized. Motion was made to approve the election of the proposed slate of officials. Motion was seconded. Motion was carried unanimously. Andy welcomed attendees to stay for beer and wine following the meeting to welcome the new volunteers and thank the retiring volunteers.

## **Neel Gupta, V.P. Planning**

**Danny Feig Sandoval** reported the city's traffic plan for Krog Street, Elizabeth Street, Lake Avenue, and N. Highland Avenue (KLENH) Transportation was approved by city council. The plan will now be an amendment to City of Atlanta's plan. The next step is to approach developers for funding, along with other funding options. All projects will require studies and evaluations by engineers; however,

the plan after eighteen months or more of work has been approved. The earmarking of impact fees assessed on developers for projects was maintained in the approved plan.

## **Morgan Shallcross, V.P. Zoning**

**El Bandito** in L5P's, 1083 Euclid Avenue was deferred. **Café Izakaya** was in attendance but not presenting.

**Kevin Ouzto** presented his plan for opening The Cockentrice at 99 Krog Street in August 2014. He is requesting a Liquor License serving beer, wine and spirits. Hours are to 11:00 p.m. weekdays and 12 a.m. weekends. Immediate Neighbors, five attending, were unanimously in support of approval. His interest was bred by his mother, a local restaurant owner in Atlanta. He has extensive culinary credentials, which include Le Cordon Blue, The Fatted Calf, Restaurant Eugene, and The French Laundry among other business pursuits. Venue includes a full service restaurant with a cheese and butcher shop onsite. Motion was made to support the Immediate Neighbors recommendation. Motion was seconded. Motion carried unanimously.

**Michael Sard** representing Barcelona Wine Bar's new pursuit Barteco presented their appeal to the City for relaxation of distance requirements to a city park (The BeltLine.) Relief of 40 feet was sought, noting that actual play structures were over a mile away from their proposed site. The venue is a connoisseur wine shop that focuses on education and specialty wines. Classes will be held twice weekly, incorporating and introducing a varied selection. There will be no patio and no kitchen, though appetizers may be catered from Barcelona Wine Bar during tastings. Three Immediate Neighbors attended. It was noted that one attendee at the IPNA meeting was not noticed by fliers. Hours were discussed. No beer or spirits are to be served. Exceptions to the concept requiring legislation are capped at one venue for 280 Elizabeth Street. Leased space is 1700 square feet. Motion was made to support the Immediate Neighbors recommendation. Motion was seconded. Motion carried unanimously.

## **Molly McLamb, V.P. Zoning**

**Ute Banse** presented plans for the expansion of the home at 829 Virgil Street; owners are **Mark Crump** and **Becca Dawsey**. Project includes: addition of a patio area with French doors, a back addition, and extension of the roofline. The front of the house will not be altered. There are no setbacks of lot or height variances required. Five Immediate Neighbors unanimously approved their plans; a vote to support the neighbors' recommendation was unanimous.

## **Tony Neu, V.P. Public Safety**

Tony is exploring options for real time communicating with neighbors about timely alerts and warnings. Next Door.com as an option is being considered. Please contact Tony with any comments or suggestions you have. A Next Door posting resulted in the arrest of six individuals recently on burglary charges. Tony reemphasized that communication is the key to fighting crime. A suggestion from the floor was made to tag public safety alerts as "BOLO." Tony also suggested that package delivery be made to a facility rather than delivery to your door. Tony and Zone 6 officers walked Bass Fields. Campers were informed they would be ticketed or arrested if they stayed on park property after midnight. Please report illegal campers and vagrants to Tony.

# 5 Things You Should Know About Our Schools This Summer

School may be out, but school politics will be hot this summer.

To help you along we compiled these 5 Education conversation starters for your summer time parties.

## 1. What do you think about the new school superintendent?

Atlanta Public Schools new Superintendent is Meria Carstarphen. She comes from the Austin school district and will earn a salary of \$375,000 dollars. Carstarphen spoke to the Atlanta Press Club in May and said that she is highly focused on the kids, "We are talking about children first, we spend less time on the politics, we spend less time on adult issues and we make the right decisions for the right reason and the right moment, so we can move forward."

Carstarphen also promised to be open and transparent. Many within APS hope that her hiring will signal an end of an era of cheating and accreditation problems. And, according to Carstarphen, all of that should be achieved in an open and transparent manner.

## 2. Have you looked at the budget for Atlanta Public Schools?

Next year APS plans to spend a record \$658 million on 50,000 kids in 100 schools. It includes pay raises, eliminates furlough days and expands charter schools.

The budget passed with a vote of 6-3 and one dissenting voice came from board member Jason Esteves who said that this budget is not necessarily taking steps towards placing funds in the classroom or cutting positions in the central office.

Matt Westmorland, the APS board member who represents Grady High School supported the budget, saying that it will finally give pay raises to teachers and eliminates furlough days. He did say, however, that it's not a perfect budget.

## 3. Have you heard about the new and old principal?

As one of 10 new principals recently approved by the Atlanta Public Schools board, Timothy Guiney takes over leadership of Grady High School on July 1. Dr. Vincent Murray was let go by Superintendent Errol Davis after running Grady for over two decades. Guiney has worked for 12 years in the Clayton County School District as both an administrator and an educator and most recently, was principal at Adamson Middle School.

Inman Middle School will get a new-old principal. For the new school year, Inman Park neighbor Betsy Bachman returns to the job she left three years ago.

## 4. Are you going to vote?

There will be a runoff election on July 22 for State School Superintendent, on both the Democratic and Republican side. So, go vote!

Richard Woods (R) - Retired School Administrator, Ex-Teacher and 2010 Candidate

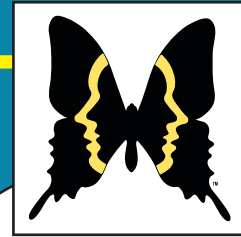
Democrat candidates include:

# Honor the Historic Regulations

I get that folks move to Inman Park for a variety of reasons like the fact that our neighborhood is cool and fun. But, when buying a home in Inman Park, you accept that along with home ownership in one of the coolest neighborhoods, you also accept the responsibility of honoring the history and historic value of our homes. To assure our neighborhood is protected, we have Historic District Regulations that govern what we can and cannot do with our homes. The regulations are meant to preserve Inman Park's historic character and prevent changes that would detract from its specific look. Adhering to the regulations and the procedures guarantee the neighborhood we leave for future generations maintains the aesthetics that drew most of us here in the first place.

But, when folks decide to try to skirt the regulations, they are flipping the finger to the values we hold dear and it is an insult and affront to all of us who do follow the rules! To me, the people who feel they are entitled to not play by the rules are like the able-bodied jerks that park in handicap spaces.

With the wrangling and multiple plans revisions I had to do, the additional expense, to meet the requirements to get my CoA approved, "trolls" that try to "slide" their renovations "under the radar" infuriate me! That's why on Wednesday April 28th, I was screaming from my deck (which the AUDC made me reduce in size to stay under FAR) at my neighbor when he came out to look over the huge, non-permitted deck he just had built without AUDC approval or a permit.

A few months ago, he asked my advice about his desire to build the new deck. He and his wife have only lived here a few years and he was not familiar with the process. I told him in detail about the process, about filing a CoA with the AUDC and explained that there are good reasons for us, as responsible custodians of our homes in Inman Park, to adhere to the Historic Regulations. I also told him that people who try to do their projects "under the radar" without following the proper procedure often wind up in direct opposition to the regulations. And that I despise those people because of their flaunting of the regulations. He asked me if I would "turn him in" and I told him that if he followed the process, he wouldn't have to worry about being "turned in". He ignored my advice.

The original Inman Park was established in the late 1800s. My neighborhood, the Hale-Stickland plat, in the early 1900s. The area past Freedom Park to North Highland was annexed during the establishment of the Historic Districting. This is important stuff. If you don't understand and respect historic importance of facts like

that the houses on the southeast side of Virgil Street were built in the 1920s for the single men and young marrieds that worked for the railroad and the Atlanta Stove Works, how are you to understand and respect that those houses must remain single story and not be built up? To prevent that loss of historic value is why the Historic District regulations were put in place and why we, as custodians of our beloved neighborhood must honor those regulations. Follow the protocol. You really DO NOT know better than the bodies that established and maintain the Historic District Regulations!

There are reasons the regulations are in place. Those reasons are to maintain the historical values of our community and to assure we have sustainable living spaces. The process is really quite simple and, if you are not like me and don't tick off the AUDC, you can get through the process relatively painlessly and inexpensively. Do your due diligence.

First, review the Inman Park Historic District Regulations on the Inman Park website ([inmanpark.org](http://inmanpark.org) About > Useful Information > Historic Regulations) to make sure the project you want to do will meet the regulations. If the changes you want to make are compliant, download, read the instructions and complete the required Certificate of Appropriateness from the City web site ([atlantaga.gov](http://atlantaga.gov) Government > Departments > Planning & Community Development > Office of Planning > Forms & Applications).

Contact Inman Park's VP of Historic Preservation, Molly McLamb, ([historic.preservation@inmanpark.org](mailto:historic.preservation@inmanpark.org)) and get her advice on preparing your CoA.

Draw, or have drawn, plans for your project specifying elevations, setbacks and FAR. Be sure and detail all materials. Learn what is acceptable, such as restoring

original windows instead of replacing them, and what is not acceptable, like replacing original wood siding with HardiPlank.

Take your completed CoA down to City Hall to the Atlanta Urban Design Commission and pay the CoA fee, \$10.00 for a Type I, \$100 - \$200 for a Type II, III or IV. If your CoA requires more than a staff review, you will be notified your project will be scheduled for a committee review. If your project is a Type III, an Immediate Neighbors' meeting will be scheduled so your neighbors can learn of the scope of your project. (Although results of the Immediate Neighbors' meeting technically do not affect the decision by the Urban Design Commission, the AUDC is sensitive to the outcome of those meetings.)

Once you are approved by the AUDC, take your approved plans to permitting, also in City Hall, pay the permit fee and get your building permit.

That's it. It isn't rocket surgery! Just a little inconvenience and expense. A lot worse than ticking off a neighbor who files a complaint and the City Building Inspectors placing a Stop Work order on you, fining you and making you go through the process anyway! **M**

# Atlanta Urban Design Commission (AUDC) Update

Please note: If you wish to perform any construction work (beyond routine maintenance) on the exterior of a site, home, or building in the Inman Park Historic District, you must contact the AUDC to begin their review/approval process. Please contact me at the email address above as early in the project as possible to schedule meetings and be placed on the monthly IPNA meeting agenda, or for any questions related to the historic regulations or approval process.

## Beef Tenderloin Sliders with Horseradish Sauce and Pickled Red Onions

## Recipe of the Month

### Beef Tenderloin:

6-8lb beef tenderloin  
1/2 T lemon pepper

1/2 T garlic powder  
1/2 T onion powder

2 T Coarse Kosher salt  
1 T Fresh cracked black pepper

Heat one side of your grill to high heat. Season the tenderloin with lemon pepper, garlic powder, onion powder, salt and pepper. Sear the tenderloin about 3 minutes per side over the high heat. Turn the grill down to medium. Move the tenderloin to the other side of the grill and cook for about 20 minutes per side on INDIRECT heat. If you like medium rare (red juicy center), remove when the meat thermometer says 130 degrees. For medium (pink center), 140 degrees. Let sit for about 30 minutes before slicing. Slice in 1/4 in. slices. Can be made in advance and served hot, cold or room temperature.

**Rolls:** Awesome, fresh, soft slider rolls are the first ingredient because with sliders, it all starts with the bread.

### Horseradish Sauce:

1 c. low fat sour cream  
1/4 c. prepared horseradish

1 tsp. Dijon mustard  
1 tsp. fresh lemon juice

1/4 tsp. sea salt

In a small bowl, thoroughly combine all ingredients. Cover and refrigerate for at least one hour. This can be made 1-2 days in advance.

**Pickled onions:** Thinly slice a red onion. In a small pot, heat about 1 cup of red wine vinegar, 1T salt and 1/4 cup of sugar until the salt and sugar dissolve and the vinegar is hot. Remove from heat and add the onions. You may need to push them down until they are all covered in the vinegar. I usually place something heavy on top to keep them submerged. Let them sit there for a 2-4 hours and they will be pickled. You can see how much they will 'cook' with the warm liquid and the pickling process. You can keep them in an airtight container in the fridge for at least a week.

**Mixed Greens:** You can use any lettuce of your choice but I like the look and taste of mixed greens on this one.

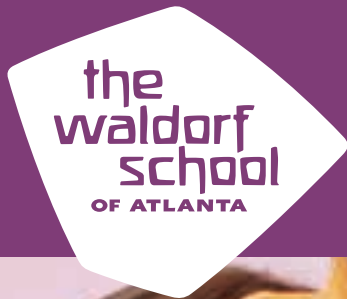
**Gouda:** We suggest using a cheese that is creamy and would not overpower the other flavors.
