## Keeping the Faith, Moving the Needle

To use a baseball analogy, when an Atlanta Brave hits a three-run homer, it is exciting and usually makes the evening news. But in reality it's a string of singles and alert base running that leads to the truly BIG innings!

And so it is in the life of a neighborhood like ours. We LOVE the splashy "home runs" as it were. Last month's big play

was the decision by the City's development arm, *InvestAtlanta*, to sell our beloved Trolley Barn to the neighbor-led group that has been operating it for years as a charming event venue open to the public at reasonable prices. It is the little hum-drum, tedious tasks that lead to big splashy victories like these.

To cobble the winning Trolley Barn proposal took several evening meetings, required multiple neighbors to put words on paper, took several draft versions, and then required that 30 pages of text be proofread to ensure that every "i" was dotted and every "t" was crossed.

Speaking of proofreading, a small group of neighbors have to plow through 20 pages of *Advocator* copy each month, with the same objective. You can see their names at the bottom of page three each month. Their names probably belong at the TOP!

These are but examples of the undramatic, sometimes boring dayto-day efforts that are the true lifeblood of a successful organization of any kind, whether it is a baseball team, a corporation, or even a neighborhood like ours.

We are all aware of the pressing need for crosswalks in Inman Park, and indeed at virtually every IPNA meeting, public officials are reminded of this. The fact of the matter, for better or worse, is that the eventual appearance of adequate crosswalks and, later, pedestrian crossing signals and the like, will be the result of little-known efforts such as those by neighbor **Janice Darling**, for example, who painstakingly catalogs our intersections and enters them into a spreadsheet that gets uploaded to the City's new "311" system. Also deserving mention are the countless early-morning Transportation Committee meetings convened by neighbor **Danny Feig-Sandoval**.

Some months ago a thread on the infamous Yahoo group decried the lack of public trash receptacles in the neighborhood. Neighbor **Alison Gordon** responded by offering to develop a map denoting those few receptacles that exist and those locations where new ones are needed.

Another recent neighborhood "home run" was the announcement by Atlanta Public Schools that they will convert the old, vacant Howard School to our west into the Grady cluster's pre-eminent middle school! Several years ago, Inman Park neighbors including **Tamara Jones** and **Regina Brewer** among others, submitted an unsolicited "white paper" to APS proposing the idea in the first place. Complete with conceptual drawings and cost estimates, prepared during their copious free time (e.g., when their toddlers might finally lay down for a nap).

I am naming only a few of the dozens if not hundreds of names it takes to do the day-to-day often humdrum tasks that eventually lead to big successes that get on the front page.

One final example is that dozen or so neighbors of our Public Safety Committee have volunteered to be Street Captains. Happily, we've seen no TV news trucks covering heinous criminal acts lately. Could this be at least partially because these folks are becoming more involved?

I think "yes", but on any given day one might wonder if one is making a difference. Our continued success, I'm convinced, is a matter of faith that working together day-to-day will move the needle and, every now and then, may result in a big "win" that we read about or see on TV. It only happens if we each of us gets involved in one way or another. Happy Holidays, Neighbors!

## **IPNA Business Meeting Minutes**

**President Dennis Mobley** called the meeting to order at 7:31 p.m. A motion was made, seconded and approved to add to the agenda a land use amendment for 670 Dekalb Avenue.

#### Newcomers: Roy Biswajit

<u>Minutes</u>: A motion was made, seconded and carried to approve the October Minutes.

Announcements: Oreon Mann announced the IP Book Club Book Swap on December 13 at 1:30 p.m. at 1046 Washita Avenue. Bring a book and a dish, both to be shared. Marge Hays announced that Tim Keane, new Atlanta Commissioner of Planning and Development, will be speaking Monday, November 23 at 6:30 p.m. at the Atlanta Preservation Center. Steve Hays announced that InvestAtlanta has cleared the way for the AESRC to purchase the Barn.

<u>Police officers' reports</u>: **Investigator Watkins** reported a few car break-ins. To suppress holiday crime, more officers are in areas with the greatest risk.

*IPNA officers' reports*: Dennis Mobley, President, asked for ratification of the board's appointment of Rick Bizot, replacing Tonya Marlatt as V.P of Zoning. It was moved, seconded and carried. Dennis asked for authorization of the 2016 Festival and Tour of Homes. It was moved, seconded and carried.

**Brian Roof, V.P. Historic Preservation,** announced plans for renovating 193 Battery Place. Four immediate neighbors voted against supporting the project with two immediate neighbors abstained. The owners will rework the plans, hold another immediate neighbors' meeting and appear before IPNA.

**Barbara Leach, Treasurer**, reported significant contributions for IPSP in October from the Wine Stroll and filming.

Michaela Kendall, V.P. Planning, introduced Stacey Patton, Director of Real Estate and Asset Management for the Atlanta Beltline, who asked for support for an amendment to realign the Eastside Trail with the stairs at Dekalb Avenue. Beltline, Inc. has secured a future tunnel easement in case Hulsey Yards closes. Beltline, Inc. hopes the changes offer a better opportunity for development. Developers will have to meet overlay setbacks and provide extensive clean-up and flood remediation. North American Properties has an option to develop and is considering a five-story mixed-use building. IPNA has considered changing its bylaws to make its western boundary the Atlanta Beltline. This new alignment would mean IPNA would give up control of half the 670 Dekalb parcel. It was moved, seconded and approved to ask the Bylaws Committee to maintain the current boundary, meaning part of the parcel would remain in Inman Park and part in the Old Fourth Ward. A suggestion was made to work with Old Fourth Ward to create a cooperative plan for zoning. Seven immediate neighbors previously voted unanimously in favor of the amendment. It was moved, seconded and approved 20-0 to support the immediate neighbors.

Rick Bizot, NPU-N: no report

Rick Bizot, V.P. Zoning, announced 1) application for Change of Agent for Liquor License for X5 Entertainment, LLC d/b/a Variety Playhouse. They are seeking: bringing in a food and beverage operator; licensing and expanding the second floor bar and adding distilled spirits. No immediate neighbors attended the meeting. It was moved, seconded, and voted 21-0 in favor of supporting the application. 2) Govinda's Cafe at 1150 Euclid Avenue is seeking a reduced parking special exception. Attorney Jackie Hilliard presented for Roy Biswajit, owner of the restaurant, to reduce the required parking spaces from 53 to 5. Ten immediate neighbors supported the application unanimously with conditions: 1) in the event Mr. Biswajit is no longer associated with the business, or the business changes to something other than a vegan restaurant, the special exception granted herein shall immediately expire; 2) total square footage of the business shall not exceed its existing square footage of 1,008 square feet; 3) other than the business website, the Applicant shall not advertise the business to potential

customers outside of Neighborhood Planning Unit N; 4) the business located at the property shall open no earlier than 11:00 a.m. and shall close no later than 10:00 p.m. It was proposed that IPNA offer a memorandum of understanding specifying the conditions. The owner agreed to sign. It was moved, seconded and approved 21-0 to support the immediate neighbors with the specified conditions.

Chris Coffee, V.P. Public Safety: no report

James McManus, V.P. Communications, reported 428 people in the neighborhood database. Emails will go out in about a week asking residents to update their profiles. Sandy Hoke pointed out that given problems with USPS, IPNA might think about additional ways to notify immediate neighbors in addition to sending postcards. Jan Keith asked if Evites to the holiday party went out to all members because she didn't receive one. James MacManus asked that anyone with missing Evites contact him and said next year's invitations will come through Memberclicks. Jan offered thanks to Chris Coffee for posting the Georgia Power number during this evening's outage.

<u>Committee Reports</u>: Danny Feig-Sandoval, Transportation Committee Chair, reported many frustrations involving new crosswalks at Elizabeth and Lake and said IPNA might consider a part-time lobbyist to deal with the city since there is so much work to be done. The Commissioner of Public Works, Richard Mendoza, has agreed to meet with the Transportation Committee.

#### Beverly Miller, Secretary: no report

#### Old Business: none

<u>New Business</u>: Randy Bailey asked which company is laying all the fiber in IP streets and was told that AT&T is working on Elizabeth Street currently while other contractors installing Google fiber recently damaged a gas line on Lake Avenue.

The meeting was adjourned at 8:49 p.m. M

## Public Safety Update

#### The Inner Workings of APD Patrol car and the 911 Center

This is an on-going piece continuing from last month's Public Safety Update! I will now share the inner workings of the APD Patrol car and of 911 Operations.

The typical patrol car has one officer to a car and a mobile data terminal (MDT). The officer can use the MDT to run tags, look up names, and view Fulton/Dekalb County Jail booking photos. The car also contains a radio and a shotgun or patrol rifle. Officers receive verbal 911 dispatch over the radios with further details on the call coming in on the computer.

Every 911 call goes into the Atlanta 911 center, a location pops up, and it is taken by a civilian call taker. From a cell phone, the caller's location is pinpointed to the nearest cell tower. If the caller is near the border of the city, that tower may be outside the APD jurisdiction and confuse the call taker. From a cell phone, it is best to call the 911 center directly at 404-658-6666. A location will not pop up for this direct line and you can give the call taker your exact location without any discussion.

After the 911 call taker receives all the information, they prioritize the call before it is sent to the appropriate zone dispatcher. Priority 1 is rarely used and saved for Officer down calls. Priority 2 is an active incident where someone needs immediate help. Lastly, a Priority 3 call is one where no one is in immediate danger, i.e. reporting a car break-in that happened overnight.

## **Transportation Committee Update**

After much persistence, Janice Darling scheduled a meeting with Nursef Kedir (City of Atlanta Chief Transportation Engineer), Janice Darling, Tamara Jones, and me, to discuss what the city was planning to do with regard to the crosswalks at the intersection of Elizabeth Street and Lake/Austin Avenue. The city's short-term plan, based on Mr. Kedir's engineering judgement, is to require anyone walking North on Elizabeth Street wanting to cross over Lake Avenue to cross over Elizabeth Street going east, then cross Lake Avenue to the dry cleaners, and then cross Elizabeth Street again to get back to Inman Quarter! In other words, this requires one to increase their chances three times of getting hit by a car as opposed to crossing at a slight diagonal following the path of the sidewalk. We made this alternate suggestion to him at the meeting claiming that by crossing at the same angle of the sidewalk would place you at the same distance as the access ramp straight across from the dry cleaner. He said he might consider this, but felt it wasn't safe. He did agree with our request to remove a few parking spaces that are actually in the Elizabeth/Lake intersection. We continue to have frustrations with this particular City Engineer who is in charge of transportation concerns and plans to address these sidewalk issues with others from the city. The long-term plan

at this intersection is to have a scramble light installed which will stop traffic in all directions allowing pedestrians to cross in any direction. This is part of our city bond referendum request list, all of which is still pending final approval by City Council.

It is unfortunate that we live in a city where we allow developments like Inman Quarter and Krog Street Market to be built while the city makes absolutely no changes to the affected intersections around these developments. The developers pay a large sum of money in impact fees, none of which are dedicated to the area impacted by the development. The developers of Inman Quarter and Krog Street Market, JPX and Paces, have stated a willingness to work with the city on intersection improvements, but they are unwilling to make the improvements without the city's approval. Evidently, City Council is discussing a new plan to make impact fee dollars available to the areas impacted by developments. We will have to wait to see if actually get any of the bond money for our City Council approved KLENH transportation study, funded by Councilman Kwanza Hall's office. We have so many concerns to be addressed that perhaps it is time we spend some money on a neighborhood advocate who can work the proper channels of City Hall to get our projects implemented.

Notes from the November 23, 2015 meeting:

#### **PRESENTATIONS:**

Parks Department: Tom Cullen reported that some of the repairs of the tennis courts at Candler Park are on hold due to cold weather.

Department of Public Works: Dennis Muma reported that crosswalks had been installed at the Lake/Elizabeth intersection. When asked why only 3 of the 4 crosswalks had been installed, he responded that he would look into it.

Mayor's Office of Special Events: Ben Klehr, NPU-N's representative to the City Council's working group on special events, reported that they have had two meetings so far: one to review how MOSE works and one where Doug Boss (Parks Department) presented the special events approval process for City parks.

#### LICENSE REVIEW BOARD:

Brad S. Syna (Variety Playhouse, Convention Center, 1099 Euclid Ave NE, Inman Park & L5P); Change of Ownership request for liquor license (existing location) and new license for balcony bar. Applicant received support from IPNA and L5PBA. NPU-N Board voted 7-0 (with 1 abstaining) to support.

Stephen A. Harvey (Cafe Highlands, Restaurant, 640-644 N. Highland Ave, Poncey Highland); Additional facility request for liquor license (existing location). Applicant received support from PHNA. NPU-N Board voted unanimously to support.

#### **BOARD OF ZONING ADJUSTMENT:**

299 Moreland Ave NE (V-15-222, Candler Park/L5P); seeking a special exception to reduce the number of required offstreet parking spaces from 54 spaces to 32 spaces to allow the conversion of retail to restaurant. Applicant received support from CPNO and L5PBA. NPU-N Board voted 7-0 (with 1 abstaining) to support.

835 Kirkwood Ave SE (V-15-266, Reynoldstown); seeking a variance from zoning regulations to reduce the required front yard setback from 30' to 23.1' and the required West side yard setback from 7' to 3' and increase the allowed lot coverage from 55% to 61% for a second story addition and rear deck addition to a single family residence. Motion to reconsider last month's vote passed unanimously. Applicant received support from RCIL. NPU-N Board voted 6-0 (with 2 abstaining) to support.
