## What Drives Change?

Spending is a reflection of values. Atlanta voters chose in 2016 to allocate T-SPLOST money for street safety and public transit, but many of the planned improvements have sadly been "reprioritized." Innovations in transportation have since made our infrastructure even more obsolete. This problem is not new. In 2004, Dirk Van Laak wrote in his book,

Technological Infrastructure, Concepts and Consequences, "It is often suppressed or forgotten that the history of most infrastructures is marked by disasters and mistakes, new dangers and new risks."

There was a time when infrastructure spending prioritized walkability, when there were more paved sidewalks than paved streets. In 1904, our city spent \$14,803.16 for the construction of 0.33 miles of streets and \$34,752.08 for 6.11 miles of sidewalks. Every city's streets were public spaces, full of pedestrians, vendors, and children at play, all sharing the space with slow moving horse-drawn carriages, wagons, and streetcars that posed little threat to public safety. It was like Streets Alive every day.

But suddenly, out of nowhere, strange new devices appeared! The first one traveled at four miles per hour. Presciently, a man walked ahead of it waving a red flag to warn the people in the streets of the coming danger. These new devices proliferated rapidly and got much faster. Within a short time, annual pedestrian fatalities skyrocketed nationally from fewer than 500 to over 15,000 as more and more of them barreled down streets, reaching speeds up to 45 mph. Their drivers were regarded as murderers, consistently blamed for accidents, and routinely charged with manslaughter, their behavior seen as a selfish and violent intrusion upon the formerly peaceful street scene. The devices were derided as toys and were called "pleasure cars." Newspapers blamed their drivers for accidents and covered traffic deaths in detail. A 1924 New York Times headline proclaimed "Nation Roused Against Motor Killings." Editorials depicted the devices as Grim Reapers mowing down innocents. A New York City magistrate declared, "The slaughter cannot go on. The mangling and crushing cannot continue."

Activists waged campaigns. "Every car should be equipped with a device that would hold the speed down to whatever number of miles stipulated for the city in which

the owner lived" demanded one article published in 1920. Car sales slumped. Anti-car legislation loomed. But the auto industry began to lobby against any and all measures to limit drivers' freedom and to work to legally allow cars to take over city streets.

Before cars, pedestrians crossed streets wherever they wanted. By 1925, new ordinances required the use of crosswalks. The new crime of crossing elsewhere became known as "Jaywalking," a word invented by the auto industry. The word "jay" meant "hick," a person who didn't understand how to get

around in the city. Industry-backed ad campaigns shamed people who didn't use crosswalks and framed pedestrian deaths as the fault of the pedestrians.

Shared streets were doomed. Newspapers' allegiances changed when they began to profit from selling car ads. Within a short time, the auto industry successfully shifted the blame for street deaths to pedestrians. Drastic changes in infrastructure spending were made to accommodate cars. Today our streets are packed with them, our streetcars are long gone, pedestrians feel threatened, and users of alternative modes of transportation have little space to operate.

In 1921, an author writing for pro-car Motor magazine stated "It is impossible for all classes of modern traffic to occupy the same right of way at the same time in safety." This statement has never been more true than in our city right now. The proposed IPNA budget for FY2020 features large line items for infrastructure, namely lights in Freedom Park and improvements for neighborhood sidewalks.

These priorities reflect our closely held values of safety and walkability. IPNA has also worked with the city to plan safety improvements along North Highland Avenue and at the Edgewood-Euclid intersection, and the city assures us these changes are coming. But we need so much more.

The advent of LIT (light individual transportation) devices has simply made the required changes more urgent. Some people view them as dangerous playthings and their drivers as selfish and reckless. Sound familiar? Can our streets accommodate these new devices? Until recently, government forces have been at work only to regulate and slow them.

But last month, the Atlanta City Council authorized a study to investigate reducing the speed limit for cars on all city streets to 25 mph. Studies show that for cars traveling at 20 mph, the risk of pedestrian death is 6%; at 30 mph, 19%; and at 45 mph, 65%. Also, the faster cars are moving, the more likely drivers will be unable to avoid collisions. Many would object that drivers will continue to exceed any posted speed limit, but a counter-argument can be made that a driver going 10 miles over the speed limit would be going 55 in a 45 mph zone but only 35 in a 25 mph zone, so non-drivers would be safer.

There are other hopeful signs. Mayor Bottoms has unveiled a \$5 million plan to add 20 miles of LIT lanes on city streets with the goal of constructing eight miles by the end of 2020 and 12 miles by the end of 2021. APD has also increased fines for blocking LIT lanes to \$100 for cars and to \$1000 for large trucks, with enforcement by ATL Plus. APD asks that anyone who sees a vehicle parked in a LIT lane call 911.

Safe streets for all should be our priority. One hundred years ago, the freedom to use city streets was largely given over to drivers of cars at the expense of everyone else. What will be the outcome this time? Can we accommodate multiple modes of transit while keeping everyone safe? Our city desperately needs to prioritize spending for shared streets as well as for better public transit.



I am the devoted owner of two middle-sized dogs, both rescues and both with high energy levels. I am not alone. My neighborhood of Inman Village is full of loving dog owners, most of whom are proud of the fact that they are nurturing rescue dogs and many of whom do not have back yards in which to exercise their animals properly.

#### Freedom Barkway

In our near vicinity we have beautiful parks but our dogs need to be kept on leashes at all times. So where can they run? The answer is simple: Freedom Barkway. Freedom Barkway is a two-acre, community-run dog park in Midtown Atlanta. It is a heavenly place according to my 3 year old boxer pit Rosa. #### Why the lament?

Simply put, this public park is in crisis. It is suffering from erosion. It is pitted and rutted and fairly unsafe for humans to traverse. The fencing is in dire need of mending, mainly due to the lawn mowers on Freedom Parkway, which crash into the fences from the other side and open up holes for our dogs to escape through. To add insult to injury, the water system is leaking so badly that we now have a festering muddy pool at the entrance to the park.

#### The good news:

They are constantly raising money and they persistently ask the Atlanta City Council to come and address the urgent repairs that are needed. If you read earlier installments of this column, you know that a sunnier Inman Park will be a hotter Inman Park. Hotter, in fact, by as many as 10-15 degrees. And you know that not all trees pull their own weight in furnishing us with ecosystem services.

Here's another aspect of the question. Trees reduce crime. In a California study, nine out of ten incidents of vandalism and graffiti occurred in areas without plantings. In Chicago public housing, the greener the environs, the fewer the crimes. A comparison of similar subdivisions in Tallahassee revealed that greener yards meant fewer property crimes. In Portland, residential street trees and large yard trees were found to be associated with less crime. Interestingly, smaller, view-obstructing trees were associated with more property crime.

None of this should be surprising. We know that trees can be an important factor in encouraging us to use and "take ownership" of our residential outdoor spaces. And as for acts of crime, we also know that urban crowding, high temperatures, and high levels of noise create mental fatigue, and that mental fatigue —impairment in cognitive processing, irritability, and impulsivity — can contribute to outbursts of anger and even violence.

To sum up: unless we make a stronger effort to plant shade trees in our yards, we could well be on our way to a hotter, unhealthier, and less safe Inman Park.

## Joel Hurt Live Oak In Springvale Park Update

Regrettably, the toppled tree did not survive. Tree Watch and the Springvale Park Committee will be working together to create a landscaping plan for the north end of the park and to replant the oak. Look for details in a future issue of the Advocator.

## Atlanta Public Schools and Superintendent Carstarphen's Contract

Atlanta Public Schools (APS) has been known for its less than perfect school system where cheating scandals reigned, many of the schools were low performing, and change in leadership constantly disrupted its reputation. Most people sighed a sigh of relief when Meria Carstarphen was hired five years ago as the APS superintendent, APS' latest solution. It seemed like a perfect fit. Carstarphen dazzled us all with her wit and wisdom; she connected with the Grady Cluster, and we felt we were heard. The years of no transparency were over, though scars of redistricting had yet to fade. When Carstarphen talked, little by little, these scars faded, and the Grady Cluster had hope and promise of a better future, a future of which we were to be a part.

Carstarphen was plucked out of Austin, Texas after three years trying to turn their schools around; her contract had not been renewed. And three years before that, she had another stint with the St. Paul schools in Minnesota. Again her contract was not renewed. APS whisked her away, feeling lucky and proud of this young, determined woman with grace, out-spoken, yet refreshingly honest discourse, strength, and political savviness, who also made inroads with Atlanta businesses.

On Monday, September 9th, when the Atlanta Board of Education (ABOE) did not renew Carstarphen's contract, many people were shocked, disappointed, and outraged, while others were relieved. How could this situation have two polar opposite responses?

#### A Brief History

The previous ABOE voted twice to extend Carstarphen's contract. The first time, in 2015, it was unanimous. The second time, in 2017, the nineperson board voted 7-0 to renew the contract with two members absent, extending it until June 30, 2019. Then, on June 4, 2018, with a 6-3 vote, her contract was extended until June 30, 2020. Therefore, by July of 2019, Carstarphen knew that her contract would not be renewed again.

In the 2018 vote, those three who did not want to renew her contract expressed concerns around these issues:

- District 5 constituents worried about school culture, safety, and its teachers (Erica Collins)
- Fiscal accountability and responsibility –
   "Dysfunctional" spending habits that are not meeting the needs of addressing the students most vulnerable to educate

## What is the APS community saying?

In the community, the opinion spans the gamut from those who are incredibly irate about the decision to general surprise, to those who expressed pleasure about the decision. Where schools have been doing well, there seems to be more disappointment and anger surrounding the decision, whereas in school districts underperforming, the general sentiment is one of relief.

There are many sides surrounding the ABOE not renewing Carstarphen's contract. There is no right answer; hopefully we can engage in thoughtful discourse around this topic.

## What Questions Can We be Asking?

We can ask the ABOE (Leslie Grant, Michelle Olympiadas, Erika Mitchell, Cynthia Briscoe-Brown, Jason Esteves) the following

questions: What's at stake personally for this vote? Are the board members being transparent? Do we have all the facts? Do we reach out to our board members to understand more? How transparent was the process, and how can it be improved? How navigable and how forgiving was the ABOE's work environment? How much of the graduation rate is due to gentrification and upturn in the Social Economic Status (SES)? Are things improving at a rate that they should given the financial support, board support, and community support Carstarphen has received during her tenure? What will a new superintendent decide to do if renovations at Grady High School have not begun yet?

There is no perfect superintendent, and the job is far from easy. Will we be able to find another good one? It takes someone strong, with sometimes definitive views to make changes happen. A leader cannot please all. During the process of letting Carstarphen's contract lapse, the ABOE stated that they are looking

#### Police Officers' Reports

Sgt. Soukup introduced new officer Sgt John Dixon (new to Zone 6, but has been on APD for 22 years). Together they reiterated the need for the new patrol car (the hours of patrol have increased and currently officers are using their own vehicles, which is less effective and more expensive).

Reported on the recent pedestrian armed robbery from the evening of 9/5 off Austin Avenue, and encouraged members to stay aware of their surroundings (and off phones) when walking alone at night. Reported on the car accident on North Highland on 8/31. Police officer was responding to a 2969 (fight with weapon) and hit a driver, then a bike rack while driving south on N. Highland. Beverly Miller asked about the speed limit required for a police officer in such a situation, and the Sergeants answered that there is no set limit, but they are expected to use "due care." An internal investigation is planned and they will report back results.

Joseph Drolet gave an update on the IPNA Tax Reform Committee, which is still working to compile information about all streets in IP re: appealing property tax assessment. The Committee met with Representative David Dreyer last week to extend the Homestead Exemption (https://legiscan.com/GA/bill/HB635/2019). The Committee will meet again next week and still has room for more members; please contact josephdrolet@bellsouth.net if interested.

Carla Jeffries (Advocator Editor), revisited the plan to "Bring the Advocator home" from current publisher KDA and again produce the publication in-house. Readers may have noticed that the number of advertisements (especially from non-local businesses) have crept up, and the amount of original content has diminished over the last 6-8 years. With the help of neighborhood volunteers, the Advocator hopes to regain Inman Park ownership and keep the circulation (currently limited by KDA to 2000, and we'd like to expand to 2500).

Discussion ensued regarding the feasibility of such a large task (Q: Is the neighborhood biting off more than it can whew? A: IP produced the Advocator in house for 30+ years; KDA has only been publisher for fewer than 8 years) and whether we can instead "ease in" to this transition (A: We will work with KDA until January 2020, so there is a transition period in place, but they have also been threatening to drop us, so this may be a moot point).

Membership voted to pursue this endeavor: In Favor 65, Opposed o Still looking for a point person to sell ads; please contact advocator@inmanpark.org if interested.

#### **IPNA Officers' Reports**

President – Beverly Miller (nothing to report)

VP Historic Preservation - Sara Wittich gave another brief update on Asana Partners Krog Street Market Expansion plans per this evening's earlier Immediate Neighbors' Meeting. She reiterated that Asana had met many times with neighbors, made several requested changes, asked for no variances and has made great effort to work with the neighborhood. A recent informal meeting with Doug Young Atlanta UDC resulted in several issues being ironed out. Asana is not asking for any variances and is being flexible in accommodating neighbors' requests re: free employee parking, window design, and planting a tree line behind Waddell Street homes.

Membership voted on Krog Street Market Expansion Plans:

Motion 1: "I would like to call a vote for support of Asana plans with the addition of the conditions of the letter dated 09/05 received from Seth Black. That letter addresses a privacy fence, tree screening, and free employee parking on two floors of the butler building." In Favor 57, Opposed o

Motion 2: "I would also like to recognize that the city, planning and transportation, and the UDC should address that there is a significant issue with traffic on Krog St, Waddell St, Lake St. with pick up, drop off, deliveries, and that the issues will also increase substantially with the Hulsey Yard development." In Favor 57, Opposed o

*VP Planning* - Rick Bizot reported that the Hulsey Yards Master Plan is still "moving along" and a "near-final report" is almost ready. Again, this is not comprehensive, but a prioritization of values/ fundamentals:

• Connect New Streets to Dekalb Avenue • Establish a Public Street Grid • Embrace Modal Options • Implement Shared Parking • Prioritize Affordable Housing • Preserve the BeltLine Corridor • Advance BeltLine Rail • Integrate with MARTA • Reserve Space for a Large Park • Respect and Strengthen Height Transitions • Ensure Architectural Quality and Building Flexibility Lord Aeck Sargent urban designer and new Inman Park resident (Virgil) Matt Cherry is involved.

*NPU* – Neil Kinkopf reported on upcoming legislation for a "party house," a dwelling that is used for a commercial event. The ordinance would forbid using a dwelling as a party house in areas that are zoned as residential and allow party houses only in areas that are zoned as commercial.

Neil also updated the current situation with the "Vegan in the Park" Festival, which would close Euclid Avenue from Hurt to Austin on Sept 28 (the same day as Wine Stroll) without communication with/approval from any immediate neighbors on those blocks. The application was not presented to NPU for consideration (was deleted online) but Vegan in the Park website lists the date as "on." As an aside, the summary of how this event slipped through the cracks is representative of the current problems in the process (neighborhood NPU permit).

#### VP Zoning - Jonathan Miller

- The liquor license application for "Skinny's Hot Chicken and Hookah Hideaway" proposed for the former location of Kimi's Bistro (1126 Euclid Ave NE; corner of Euclid and Sinclair Avenues) has still not progressed far enough for review by IPNA or NPU-N despite ongoing construction activity.
- A new historic district ordinance is in the works for the Poncey Highlands neighborhood. Details forthcoming soon. (No action will be required by IPNA but NPU-N will likely weigh in.)
- 3. Reminder that the City is in the process of revising its entire zoning code. Easy fixes occurred a few years ago and slightly harder ones passed in the last year. The major overhaul is next, although as Commissioner Keane mentioned in his pre-meeting talk, there appears to be difficulty in getting this phase underway due to difficulty in procuring a vendor.
- Villa de Grip (320 N. Highland) lawsuit update: discovery phase to conclude in November 2019 with possibility of a trial in early 2020.

*VP Public Safety* -- Kevin Curry reiterated the need for and research behind the impending purchase of a new vehicle for Security Patrol [See letter from August]. Discussion ensued regarding details. Q: An extended cab SUV may be a gas guzzler. Can we instead go eco friendly? A: The IPSP needs this size/kind of car and because it is driven so locally they do not use much gas. Q: Why new – not used or leased? A: The type of car IPSP needs (no frills, no unnecessary extras) can most easily be found new, and the deal we are getting on this new car is cheaper than any we could find used.

Membership voted to approve purchase of new patrol vehicle: In Favor 67, Opposed 0

## VP for Communications - Melissa Miller (nothing to report)

*Treasurer* - Kay Kirsche presented the proposed 2020 budget, with discussion on various specifics like: Q: What about a year with a poorly performing Festival? A: We keep \$150K in reserves. Q: New line item for internal Advocator expenses/revenue? A: Will amend for final budget version. Q: LifeLong Inman Park line item should be \$1,500, not \$500 A: Will look into and amend for final Q: Delta Park improvements? A: Should be part of traffic plan re: intersection of Edgewood/Euclid.

Motion to amend those two items for October final budget/vote. Seconded. Passed 53 – 0.

Secretary - Julie Noble thanked Hampton & Hudson/Nina & Rafi's for pizza at today's meeting and reported that while we had been meeting, Atlanta United beat FC Cincinnati 20, with Josef Martinez scoring both goals.

*TreeWatch Update* – Amy Higgins reported that the old oak in Springvale Park is indeed beyond saving and will need to be removed. Allison Gordon is working on salvaging some of the wood for local projects. Jim Abbott and Eileen Brown are planning a ceremony and replanting of new tree.

"What is the Mission and goals of TreeWatch?" For the first 15 years, the goal was QUANTITY of trees in the 'hood, but now we are focusing on QUALITY. We need more share trees, and though obviously there is no room for oak trees in the street/sidewalks, given current spacing and development, the goal for the 50th Anniversary of Festival will be that leading up to and during that year we plant 50 new oak trees in people's yards and in the parks.

Amy also mentioned that the 7th Annual Beltline Wine Stroll is coming up on Saturday, September 28th and that there will be a record 30 stops on the Stroll this year, the proceeds of which benefit the Security Patrol and Springvale Park. 
